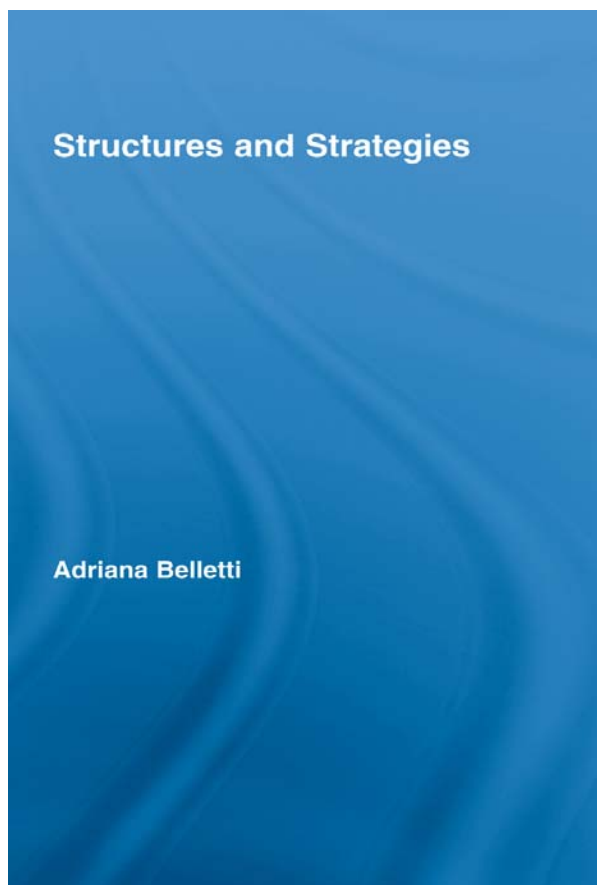


Structures and Strategies
